

*MiDD, USFS, Lake County Road Commission,
Langes and any other local property owners
Release and Indemnity Agreement*

In consideration of my use of trails and property known as the *MiDD Sweetwater Challenge trails*, hosted on and adjacent to property owned by Rick and Linda Lange and other local private property owners, MiDD (Michigan Dog Drivers Association), the sponsoring organization, the United States Forest Service (USFS) who manage the land in and around the Sweetwater Challenge trails and the Lake County Road Commission and in recognition of the fact that in such use of said trails and property for sled dog activities and the use of such private land and facilities, that injuries, paralysis or death may occur, I do hereby covenant with Rick and Linda Lange and any local property owners, MiDD (Michigan Dog Drivers Association), the Lake County Road Commission and the United States Forest Service (USFS) that I will never sue or bring legal action or proceeding against them, or their respective officers, employees or agents, for or on account of any injury, paralysis, death or damage sustained by me, which I have now or may have against them, their respective officers, employees or agents, of any nature , arising out of the use of *Sweetwater Challenge trails* or the use of the land owned or managed by the above named entities whether arising within the confines of trail use or elsewhere, or for any claim or demand I have or may have against them, their respective officers, employees or agents, of any nature arising out of any such injury, and this Release and Indemnity Agreement may be presented as a complete defense to any action or other proceeding which may be brought, instituted or taken by me, or my legal representatives, against the above named entities, their respective officers, employees or agents.

This covenant not to sue is executed by me not in satisfaction of any damages sustained, nor as compensation for injuries, paralysis or death, nor in settlement for any claim for damages: but rather is in sole consideration of my use of trails and the use of the land and property owned or managed by the above named entities.

I further hereby covenant to indemnify and save harmless the above named entities and private land owners, their respective officers, employees and agents, against any claim for damages, compensation, or otherwise on the part of me, my heirs, executors, or administrators, and to reimburse or make good any loss or damages or costs that the aforesaid indemnities may have to pay if any litigation arises on account of any claims made by me or anyone in my behalf. I further agree to be responsible for my conduct and that of my guests, children and dogs including any dogs I have leased or borrowed from someone else.
